- j. to employ any staff as may be necessary for the administration and management of the Trust properties and of the institution established pursuant to these presents and to pay their salaries and at their discretion to remove such staff to pay audit fees and incur all other necessary charges and expenses for administration and management of the Trust and the Institute thereunder;
- k. to sign, endorse and negotiate cheques, bills of exchanges, drafts, debentures, debenture stocks, GP Notes and other Government, Semi- Government, local or Public Loans, papers and instruments and to ask, demand, draw, realize, compound, sign, endorse and to negotiate all interests, dividends, warrants, bonus and other benefits to accrue in respect of the Trust properties and investments thereof;
